

Enfield Rovers Football Club is a family-oriented club in Sydney's Inner-west.

Training sessions and games will be organised by the Club's volunteer committee members in conjunction with the Club's Technical Director (where one is engaged). Coaching staff will be appointed by the Club's Committee and will be either qualified and experienced coaches or volunteers of the Club. All coaches will have the support and guidance of the Club's Committee and Technical Director (where one is engaged).

As a parent/guardian of a player who will be representing Enfield Rovers Football Club and playing under the auspices of the rules, regulations and policies of Football Canterbury Incorporated or any other relevant association, you must meet the following requirements in regard to your conduct during any such activity or event:

- 1. Remember that your child participates in sport for their own enjoyment, not yours.
- 2. Encourage your child to participate, do not force them.
- 3. Never ridicule or yell at your child and other children for making a mistake or not winning.
- 4. Remember that children learn best by example. Appreciate good performance and skilful fair play by all participants.
- 5. Support all efforts to remove verbal and physical abuse from sporting events. Before, during and after the game.
- 6. Display good sportsmanship, be supportive after the game, win or lose.
- Always respect players, coaches, officials, club committee members and other parents.
 Without them, your child could not participate and teach children to do likewise.
- 8. Respect the rights, dignity and worth of every young person regardless of their gender, ability, cultural background, or religion.
- 9. Be a positive role model.
- 10. Understand the repercussions if you breach, or are aware of any breaches of, this code of behaviour.

Penalties

If a parent violates any part of the code, they may not be permitted to attend another game, practice game, tournament game or practice session for a minimum of two weeks. In the case of subsequent violations, the parent may be subjected to further disciplinary action by a Conduct Review Committee (or Disciplinary Committee or similar), which may include a permanent ban on attending games or suspension / de-registration from the Club and Association of the child for the parents failure to adhere to the code and/or comply promptly with sanctions.

All penalties shall be assessed by a conduct review committee (or similar) upon a duly filed complaint and hearing. All decisions made by the committee shall be subject to appeal and review by the committee of Enfield Rovers FC.



PARENT CONTRACT

I hereby support my child's membership of a team at Enfield Rovers FC. I have read carefully this Code of Conduct and accept responsibility for complying with it in all respects. I will also use my best endeavours to ensure my child adheres to their obligations under the Player's Code of Conduct signed by them. I also agree and understand that sanctions may be imposed on my child and myself should either of us breach any aspect of the Codes. These may include:

- · Warnings, either verbal or in writing,
- · Removal from the field of play or stadium,
- · Disciplinary action or exclusion imposed by the Club,
- Expulsion from the Club, and/or legal proceedings.

I agree that while attending any sporting events (including training sessions) undertaken by my child with Enfield Rovers FC, I will adhere to the instructions/directions of the coach, Technical Director, or Club Committee member and abide by the Regulations, Rules and Policies of the Club and of Football Canterbury Incorporated as they apply to me:

- 1. I will act respectfully and responsibly toward the players, coaches, club officials and other spectators of all teams. Abusive, insulting and offensive language or actions are unacceptable.
- 2. I will respect and follow the reasonable directions of coaching staff, Technical Director, Club Committee Members and referees.
- 3. I will respect the facilities and equipment of Enfield Rovers Football Club and any clubs which may be utilised by my child's team.
- 4. I understand that verbal abuse and violent behaviour towards any player, coach, Technical Director, referee, club official or other spectator is at all times unacceptable and would make me liable to serious consequences (as is any sexual, racial and other form of harassment).
